

MARYLAND LEGISLATIVE ALERT

Issue: Maryland has an Exclusive Scope law requiring a license to practice dietetics. There are exemptions but they are superficial, and can cause confusion.

Analysis

Maryland requires a license to provide most types of nutrition care. It defines “dietetics” to include key words that encompass much of what anyone could do, such as: assessing, developing, determining, applying, and evaluating, nutrition counseling and education.

The Maryland Health Occupations Code Ann. § 5-103 provides the exemptions which allows for anyone employed or operating a health, weight loss, or fitness program, conducting classes or disseminating information related to nonmedical nutrition or to provide nonmedical nutritional information or to distribute nutritional literature. While this may seem broad, a practitioner is still limited to just providing general information that does not stray into assessing, determining, applying, evaluating, etc.

Recommendations

Maryland law is confusing and we should advocate for a broad, clear exemption. This action alert will be followed up with direct lobbying and working with practitioners in Maryland.

SAMPLE LETTER TO SEND TO YOUR REPRESENTATIVE(S)

June 11, 2017

Dear _____:

As your constituent, I am writing to ask that you sponsor legislation to amend the Maryland Health Occupations Code Ann. § 5-103 to allow for greater choice, more employment, lower costs, and more competition in the practice of nutrition care.

Presently, only a licensed dietician or nutritionist may provide direct nutrition care including assessing, developing, determining, applying, or evaluating, nutrition counseling and education. The law is so broadly written that it has had the unfortunate affect of giving one nutrition philosophy a monopoly over the whole practice of nutrition. No single group should have this monopoly, and no one method, practice, education, or philosophy is right for everyone.

As a supporter of holistic nutrition, which seeks to heal the “whole” body, and provide a comprehensive assessment, I would like to see a more broad and diverse choice in nutrition providers. Nutrition is not “one size fits all” and it’s important that the practice of nutrition is open to all philosophies, not only to have gainful employment and improve the health of all citizens, but to provide maximum competition which gives maximum choice for consumers and helps to lower costs.

Please sponsor legislation to clarify the law so there is no ambiguity as to whom may do what. This can be achieved by introducing the following amendment to § 5-103(d) to read:

(d) Right to provide nonmedical nutritional information not limited. -- This title does not limit the right of ~~an individual to provide nonmedical nutritional information or to distribute nutritional literature~~ anyone to provide wellness and lifestyle recommendations, nutritional guidance, counseling, analysis, or education, so long as such person does not use any title, designation, words, letters, abbreviation, or insignia, or any combination thereof, to indicate that the person is a registered dietitian or licensed dietitian.”

This exemption would immediately allow for more practitioners of nutrition care, which would help to lower costs and encourage others to seek employment in this field, while clarifying any ambiguity.
